This Renewal Agreement is made as of this ____ day of July 2018 by and between the **PORT OF PALM BEACH DISTRICT**, a special taxing district of the State of Florida (hereinafter referred to as "Port"), and **GARY, DYTRYCH & RYAN, P.A.**, a Florida Professional Association.

RECITALS

WHEREAS, Gary, Dytrych & Ryan, P.A. is currently acting as general counsel for the Port pursuant to an agreement ("Agreement") having commenced July 1, 1998, and subsequently renewed year to year thereafter; and

WHEREAS, Gary, Dytrych & Ryan, P.A. and the Port desire to extend the Agreement through July 31, 2019;

NOW, THEREFORE, in consideration of the mutual terms and conditions, promises, covenants and payments hereinafter set forth, the parties agree as follows:
